On November 21, 2025, the trustee (the "Trustee") of the share award plan of the Company (the "Share Award Plan") returned 5,085,000 shares to the Company, which will be held as treasury shares by the Company. Initially, on October 6, 2025, the Company transferred 15,000,000 treasury shares to the Trustee, which were intended to be held by the Trustee in trust for future transfer to the grantees upon vesting of the awards granted and to be granted under the Share Award Plan. However, the number of shares transferred exceeded the number of share awards granted by the Company to the grantees under the Share Award Plan on September 1, 2025, by 5,085,000 shares, resulting in the return of the excess shares.
